



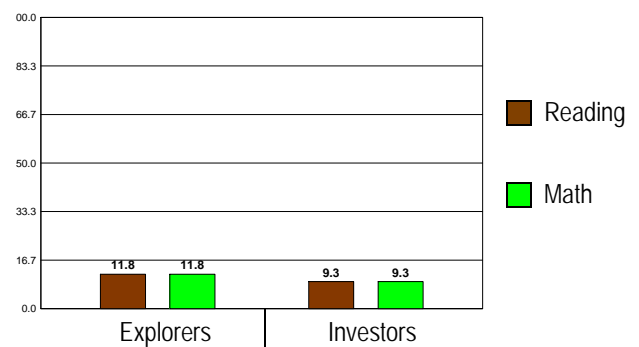

## School Summary
