- c. Triton Degree Programs
 - i. Degree programs are now 60 credit hours; down from 69 credit hours.
 - ii. The culinary certificate has no electives, and has added Food Prep II as a requirement.
 - iii. The baking certificate has no electives, and has added Advanced Cake Decorating as a requirement.
 - iv. Certificate programs do not have any general education requirements.
 - v. Degree programs require students to pass Rhetoric 101.
- d. Dual Credit Instructor Changes for Lab Classes
 - i. Current instructors will be grandfathered in and approved as dual credit instructors.
 - ii. Going forward, all dual credit instructors must
 - 1. Have an associates' degree in culinary, and
 - 2. 3 years of industry experience which equals 6000 work hours
 - iii. Triton is looking into offering summer classes at no cost to high school teachers to assist in earning the culinary degree.

b. Dual Credit

- i. Course must be articulated with Triton
- ii. Instructor must be approved to teach the course
 - 1. Resume
 - 2. Philosophy of teaching/Cover Letter
 - 3. Transcripts
 - 4. Application
- iii. Dual credit students must apply to college and take AccuPlacer test
 - 1. The group discussed the hurdles regarding high school students taking Accuplacer
 - 2. Triton faces the same hurdles and current board requirements
 - 3. Could high school PSAT scores be used?
 - 4. Why test students at all? They should re-rest upon entering Triton after graduation.
 - 5. Dual credit numbers would be much higher without Accuplacer requirement.
- iv. Dual Credit Course
 - 1. ECE110 cannot be dual credit, since it transfers to a baccalaureate degree.
 - 2. EDU110 is a dual credit class.
 - 3. The prerequisites have been removed from ECE 146 so that it can continue to be taught as a dual credit course

 - ii. Purpose of Meeting
 - 1. To evaluate the local need for a textiles program of study.
 - 2. To work on the fashion programs of study
 - iii. Local and National Labor Statistics
 - 1. The current labor statistics for textiles were presented.
 - a. Limited job opportunities at the national level.
 - b. Very limited job opportunities at the local level.
 - iv. Eva Stevens discussed the current trends with regards to textiles.
 - 1. Sustainability
 - 2. Textiles, oil, and gas manufacturing are the highest with regards to pollution
 - 3. Recycling of fabrics
 - 4. Chemists are filling textile jobs.
 - 5. Most students enter the fashion industry with a 2 year degree.
 - 6. Bolt Threads using spider webs

 - 1. Leyden has a Fashion Merchandising Pathway.
