APPROVAL OF FEBRUARY MINUTES

FY19 ACTIVITIES REPORTING

FY20 GRANT PLANNING

- A. Budgeting: Assume FY19 budget allotments with minor adjustments, as they have not been released.
- B. IWAS Submissions: ISBE due to open IWAS sometime in early April.
- **C. Regional Activities:** Admin Council recommended to continue the Triton visits in early October with one bus from each school for a campus tour in Health, Business, Manufacturing, IT, and Auto, per school. Dr. Campos requested information from the high schools as soon possible for scheduling. CISCO is unable to host an apprentice expo in 2019. Mr. Holthouse offered the districts to attend an upcoming trades fair hosted by Leyden. DVR will reimburse the schools for the bus trip expenses per school campus. Teacher Tech Trek will not be offered in FY20.
- **D. 5% Grant Funds for Industry Assessments Function Code:** Budget for industry assessment and testing fees in grant line 2230-300 for up to and no more than 5% of the total grant amount. Certiport will send invoice to each school in March of 2019.
