## Harry Ohde from IBEW Training Facility

Harry Ohde presented to our group. He said Illinois has become very aggressive in the renewable energy sector. There is a future energy bill which mandates different organizations to have training for people of IL. IBEW applied for craft apprenticeship programs and got the grant. He said there are now 17 IBEW programs in Illinois. Triton now has an agreement with IBEW and beginning in August of 2020 will have a 30 hour certificate program to help students get degrees in renewable energy. Triton is the first community college they will be working with. They are working with 3 high schools and targetting low income/diverse areas. IBEW teacher works with the teacher at the school. Grant is paying teacher salary, books, some equipment. Classes--OCEA, First Aid CPR, electrical safety, basic solar electricity.

#### Illinois CTE Counselor Academy Webinar

• Counselors from Leyden reported on the November 21st webinar, which was CTE, What Is it? They said this was a very basic webinar that our student services committee is all, already very well aware of. It focused on employability, engagemen, graduation rates. It spoke about the Perkins 5 grant, which is hoping to increase learners access to CTE.
