#### **CALL TO ORDER**

Dr. Gauthier called the meeting of the Des Plaines Valley Region Board of Control to order at 8:15 a.m. on Wednesday, June 23, 2021 via Zoom video conference.

### A. FY21 Budget Reallocation:

Dr. Cothran noted that the ISBE consultant handling the Education Pathway Grant agreed that since the Education Pathway Grant is only at the regional level and all Function/Object Codes are 4140/600, that the Director has the discretion to move funds between participating schools as needed, within the intent and purpose of the grant.

Dr. Pruitt-Adams moved, Dr. Henderson seconded the motion for the reallocation of FY20 and FY21 Education Pathway Grant funds from Oak Park & River Forest District 200 and Proviso District 209 to Ridgewood District 234, as presented.

Roll call vote. Ayes: Dr. Gauthier, Dr. Henderson, Dr. Kelsall, Dr. Pruitt-Adams, Dr. Skinkis. None opposed. Motion carried.

## A. District Transfer of Student Information to ISBE for Education Career Pathway:

Dr. Cothran noted that the DVR EFE does not handle private student information and therefore when student information is requested by ISBE, it should be handled directly between each school and ISBE according to their privacy protocols.

Dr. Pruitt-Adams moved, Dr. Skinkis seconded the motion to approve direct District transfer of student information to ISBE for the Education Career Pathway Grant. None opposed. Motion carried unanimously.
