- 2. Where is your school at? Any challenges? Any updates to the program?
  - a. Leyden: No onsite visits yet, guest speakers still are coming in to supplement.
  - b. OPRF: Clinicals at Rush OP Hospital. 6 groups 2 sections this year rotate to attend clinicals. 3 sections next year. 60 students. Students get full day release to attend clinicals.
- 3. What Dual Credit Classes do you offer?

### 7. Team Based Challenges and Perkins

- a. So something at OPRF we are working on is Career Pathway Endorsements with the P20 network and Jason Klein. One of the components of the pathway is team based challenges.
- b. Team Based Challenges: Where is everyone at? The following is from the Perkins and CTEI grant expenditure guidance document
  - i. A team-based challenge is "a group problem-based learning project relating to an individual's career area of interest that involves a problem relating to employers within that area, including mentoring from adults with expertise in that area, and requires the individual to present the outcomes of the project." (Illinois Career Pathways Dictionary)
  - ii. CTEI and Perkins funds can only be used for team-based challenges involving CTE students, aligned to coursework in approved secondary CTE programs, and overseen by appropriately licensed CTE teachers.
  - iii. Allowable team-based challenge costs are:
    - 1. Transportation to challenge events utilizing most cost-effective means;
    - 2. Student's registration/fees for challenge participation; and
    - 3. Facility, supply, and material cost associated with conducting a challenge event.

- a. Denise recommends being careful with wording when requesting through Perkins, "prizes" got denied, so it had to be reworded.
- iv. Not allowable team-based challenge costs are:
  - 1. Student hotel costs;
  - 2. Out-of-state travel for students. More than 50 miles outside of the Illinois border constitutes out-of-state.
