DISCUSSION ITEMS

A. DVR CTE Career Coordinator (Pilot Grant):

The Board showed interest in participating in the pilot grant program and asked Dr. Kuhn to submit their intent to apply. Dr. Kuhn mentioned that the Administrative Council Members recommended the Coordinator position be full-time. Dr. Kuhn suggested to the Board that High School Member Districts share the cost of salary and benefits not covered by the pilot grant. He added that the grant award could increase per recipient if other EFEs opt out.

B. DVR Website Conversion:

The Board was agreeable to the plan to update the DVR website. Dr. Kuhn said he will present this matter at the June 27 meeting for Board approval.

INFORMATIONAL ITEMS

A. FY22 Grant Expenditure Status:

The Board Members received status of grant expenditures, last updated on May 12, 2022. Dr Kuhn said Districts have until the end of May 20, 2022 to expend any unused Function 1000 Perkins and CTEI grant funds.

B. FY23 Budgets:

Dr. Kuhn announced that FY23 budget allocations are not yet available in ISBE Web Application Security (IWAS).

C. Illinois Manufacturing Association (IMA) Foundation Grant:

Dr. Kuhn reported that Leyden and Ridgewood High Schools applied for the IMA Grant totaling \$24,000.00.

D. Soft Skills American Hospitality Academy (AHA) Teacher Professional Development:

Dr. Kuhn offered to provide more information to Districts interested in the pilot program for teachers by Soft Skills AHA.

E. Triton College 'Connect2College Summer Bridge':

The Board received information regarding Triton's five-week summer bridge program from June 13, 2022 to July 14, 2022, Monday through Thursday.

F. Bill Status of HB3296 (Sch Cd-Career/Tech Ed Pathway):

The Board received Illinois General Assembly's action status updated on April 7, 2022 regarding Illinois House Bill 3296.

G. Legislative Updates:

The Board received ISBE's Board meeting minutes of April 20, 2022 on bills that passed both chambers concerning ISBE and other Initiatives, addressing teacher shortage, and new educational mandates for 2022.
